ay is the month of the year when mothers are honored in America. For many, Mothers Day is a time to remember wonderful years spent with our moms, and giving thanks for their unconditional love and support.

Many other people, though, have painful memories of their mothers, and that makes this month a difficult time for them. LSS encounters mothers and families who face many types of problems, and below are the stories of three whom we have helped recently.

CHRISTINE dropped out of high school at age 15 and started using crystal meth. Her mother and stepdad did drugs, so it seemed natural for Christine to do the same.



During those years of addiction, she had three children: a daughter who was taken by Child Protective <u>Services</u> (CPS) at age eight, another girl removed at age three, and a son who was carried away at fewer than 30 days old. Christine was in a downward spiral that could easily have led to her death. She had nowhere to turn and nobody to help. But then something happened.

She went with a friend to Lutheran Social Services in Riverside to get lunch, and before long offered to serve as a volunteer in the donated clothing department at that location. Our caseworker took an interest in her, which prompted Christine to consider what she wanted her life to be. There was a culture of hope and acceptance at LSS, and that's exactly what she needed.

LSS helped Christine obtain a California ID Card, and also assisted in finding a room for her to rent. She currently works three jobs weekly, and is enrolled at Riverside Community College, studying for an Associate's Degree in Social Work and Human Services. After graduation, she wants to do for others what LSS did for her.

Christine was recently baptized, attends worship regularly, and for the first time in her life is focused on her future, instead of simply repeating her past.

JANE came to LSS because the father of her nine-month-old child had attacked her, and she feared for her life. She fled the situation, contacted law enforcement in Long Beach, and the abuser was arrested. She and her baby were homeless, and there was no family support available. Jane needed food, clothing, and a case manager to help her work on some immediate goals: permanent housing, mental health support, education and employment. She joined our Victims Intervention Program (VIP) for those who have been physically and emotionally abused.

LSS provided transitional housing resources for Jane and her son, and they entered the House of Hope in July 2018. Jane also began counseling with LSS during that same time. She has a Bachelor's Degree in art, and is working toward becoming a substitute teacher.

Jane is committed to breaking out of the cycle of domestic violence that has controlled her, and to move on from being a victim to a survivor. She feels safe when at LSS, because we have walked alongside her in her struggles and will never abandon her.

CHARLENE began acting out in destructive and divisive ways when she was 15 years old. She had two siblings, ages 11 and nine. A couple that was not able to conceive had adopted all three children. Over time, it was learned Charlene had been a victim of sexual abuse from more than one member of her birth family. It was a generational malaise that was never addressed or treated.

Charlene entered the LSS *Our Children Project*, a very unique program in Apple Valley for children who have suffered the trauma of being sexually abused. She was placed in a group of girls, each of who had encountered the same situation in one way or another.

That was the turning point in her life. Charlene was embraced by that group of girls, and mentored by her therapist. Over a period of three years, she found a new way of living in the present, without being tormented by the past.

Meanwhile, Charlene's mother, Catherine, met with all types of parents: biological, adoptive, foster, and grandparents regarding rearing the younger generation. Catherine was enlightened on many levels, and thus prepared for the long journey back to normalcy for her daughter and their entire family.

Charlene was active in all types of activities in high school: sports, organizations that promote leadership, and a peer counseling program in which she learned how to help her classmates face critical issues in their lives. Now in college, Charlene is studying to be a social worker where she can pass along to others the loving support she received from Lutheran Social Services.
