

Dear Friend,

Lutheran Social Services assists many clients on a regular basis, and those served come from different ages and stages of life.

Guadalupe, a single mom, lived with her three children in their apartment. She was a caring mother, and the children's father had visitation with them every other weekend. Lupe worked the night shift, and the father kept them during the evening hours. It seemed like a good arrangement.

But her now ten-year-old daughter was having trouble at school. Her grades dropped, and then she asked not to spend the weekends with her father. Lupe talked with her daughter, and learned that the father had inappropriately touched the girl, and abused her sexually on two occasions. She was only eight years old, at the time.

Lupe was referred to the LSS Our Children in rural San Bernardino County. As a result of contacting the authorities, the father was arrested, and has been incarcerated since August 2018.



Lupe was happy to learn there was a group of other children who were receiving support after also having experienced sexual abuse, and that her daughter could join their session. Lupe was so relieved there was also a group for parents and guardians, whose children had been molested. She felt so alone before she turned to Our Children.

Our LSS therapists worked with Lupe, her daughter, and also her oldest son. The young girl sometimes wakes up at night, fearful that her dad will come and take her away. Lupe is learning more about the trauma her daughter experienced, and now it's easier for the two of them to talk openly and honestly with one another. The son is learning how to deal with what his father did to his younger sister.

Through group therapy, both Lupe and her daughter have discovered there is hope, having been able to access the help they need. This was a crisis in the home, and LSS responded.

#### CHILD AND FAMILY GROUP THERAPY \$100 FOR 1 SESSION

Brad, age 62, served his country faithfully in the United States Army. He was assigned to the Quartermaster Corps, and received an Honorable Discharge.

Following his military service, he worked in Big Bear as a motorcycle mechanic, but eventually found employment that kept him out of the bitter cold. He worked in a grocery store for twelve years, but when he suffered a stroke, he could no longer work.

Brad lost his home when his State Disability benefits expired, and was homeless for ten months. He occasionally spent the night in the homes of his two sisters, but beyond that he slept in public restrooms, and received physical nourishment from a food bank sponsored by Believers Chapel.

A friend told him about an LSS caseworker in Big Bear and she helped him access his benefits, a copy of his birth certificate, as well as an Affidavit of Homeless Status, which was required for the pension application of his previous employer.

Eventually, the caseworker connected Brad with the Homeless Department of the Veterans Administration. They placed him in temporary housing, and secured financial benefits due him through the V.A.

Brad was assisted in obtaining furniture and other essential household items, and now lives in Loma Linda Veterans Village. His life is back on track and he is able to sustain himself through whatever challenges he faces. Brad said of our LSS staff person: "I am blessed and feel like a human being again. That would not have happened without the support of Lutheran Social Services in Big Bear." This was a crisis because there was no home, and LSS responded again.
